

## **Exhibit 10 Specific Plagiarized Intellectual Property**

Defendants Anastasia Bendebury and Michael Shilo DeLay included plagiarized intellectual property taken without authorization from the rightful owner, Bill Gaede (the plaintiff), in the following articles posted by them in their professional Demystifying Science [DS] website.

Squarespace, Inc. of New York is the host of the platform and server on which the defendants built their DS website. Despite being authorized to do so by Squarespace, the defendants did not reinstate these articles. The plaintiff alleges that this has the effect of depriving him of evidence in the instant case. Therefore, the plaintiff uploaded the articles in URLs under his control to present as evidence in these proceedings.
